## DECREE No. 6,913, OF JULY 23, 2009 D.O.U., July 24, 2009 - Section 1

It adds provisions to Decree no. 4,074, of January 4, 2002, which regulates Law no. 7,802, of July 11, 1989, which regulates about the research, experiments, production, packaging, labeling, transportation, storage, commercialization, commercial advertisement, use, import, export, final destination of the residues and packages, registration, classification, control, inspection and the monitoring of pesticides, their components and related.

THE PRESIDENT OF THE REPUBLIC, using the powers conferred upon him by art. 84, clause IV and VI, subheading "a", of the Constitution, and in view of what is disposed in Laws no. 7,802, of July 11, 1989, and 10,831, of December 23, 2003, DECREETS:

XLVII - phytosanitary product with use approved for organic agriculture - pesticide or similar containing exclusively allowed substances, in its own regulation, for use in organic agriculture;

XLVIII - specifications of reference - minimum specifications and guarantees that the phytosanitary products with approved use in organic agriculture must comply with to obtain registration." (NW)

- "Art. 10-D. To obtain the registration or the reassessment of registration of phytosanitary product with approved use in organic agriculture, the interested part must present, within period not exceeding five working days, starting from the date of the first protocolization of the application, to each one of the responsible bodies for the sectors of agriculture, health and environment, request in two copies, according to Attachment II, items 1 to 11 and 24.
- § 1 For the registration of phytosanitary products with use approved for organic agriculture, the agronomic, toxicological and environmental studies will not be required, if the product presents characteristic, process of obtainment, composition and indication of use according to the established in the specifications of reference.
- § 2 The specifications of reference of the phytosanitary products with approved use for organic agriculture will be established based on information, tests and agronomic, toxicological and environmental studies executed by public or private educational, technical assistance and research institutions, in procedure coordinated by the organic agriculture sector from the Ministry of Agriculture, Livestock and Food Supply.
- § 3 The organic agriculture sector from the Ministry of Agriculture, Livestock and Food Supply is responsible for identifying the prioritized products for use in organic agriculture and forwarding them to the agriculture, health and environment bodies,

which will define what are the information, tests and studies needed for establishing the specifications of reference.

- § 4 The specifications of reference will be established in its own regulation by the bodies responsible for the sectors of agriculture, health and environment.
- § 5 The products which this article deals with will be registered with the denomination of "PHYTOSANITARY PRODUCTS WITH APPROVED USE FOR ORGANIC AGRICULTURE".
- § 6 Each commercial product with approved use for organic agriculture will have its own registration.
- § 7 The phytosanitary products with approved use for organic agriculture are exempted from the TSR (Temporary Special Registry) and from registration of components, when registered according to the specifications of reference.
- § 8 The phytosanitary products with approved use for organic agriculture produced exclusively for own use are exempted from registration." (NW)
- "Art. 12-B. The registration process of phytosanitary products with approved use for organic agriculture will have its own processing and it will be prioritized." (NW)
- Art. 2 <u>Attachment II of Decree no. 4,074, of 2002</u>, enters into force added by item 24, according to the Attachment of this Decree.
- Art. 3 This Decree enters into force on the date of its publication.

 Declaration of the registrant, about the qualitative and quantitative composition of the product, indicating the maximum and minimum limits of the variation of each component and its specific function, accompanied by laboratorial report of each formulator;

· Indication of use (cultures and biologic targets), form of action of the product, modality of use, recommended dose, concentration and form of broth preparation, form and equipment of application, period, number and interval of applications;

Restrictions of use and special recommendations;

Safety interval;

Re-entry interval;

Information referent to its compatibility to other products;

• Specification of individual protection equipment proper for the application of the product, as well as the measures of collective protection;

Procedures for decontamination of packages and equipment of application;

System of collection and final destination of packages and remains of products;

Label and leaflet model. "(NW)
